



# **Appellate Time Frames: A Comprehensive Statistical Examination**

## Introduction

The appellate process in a capital case is lengthy by any standards. Following the statutory changes in 1997 that created the Capital Collateral Regional Counsel (CCRC) and Commission on Capital Cases, the time to complete a 3.850 motion in the Circuit Courts was reduced by approximately 18 months - a total savings of 499.5 years<sup>1</sup> in unproductive delays. Inmates sentenced to death are automatically entitled to a Direct Appeal in the Florida Supreme Court. Affirmation of the trial court's decision, however, does not mark the end of the appellate process. The Direct Appeal is generally followed by a host of additional motions and appeals at the Circuit, State, and Federal levels. According to the Florida Department of Corrections website<sup>2</sup>, the average inmate spends 12.68 years on death row. Much of this time is devoted to appealing various court decisions. If there were systematic delays of an unusual nature at one juncture of the appellate process or another, identification of these delays would be of considerable benefit. This would allow for understanding as well as possible amelioration of the problem.

In 1997, the CCRC was statutorily created to provide more efficient counsel to individuals convicted of a capital offense in their appellate process. In the interest of examining any effects the creation of the CCRC had on the average amount of time devoted to various postconviction motions and appeals, two time periods were compared: 1968-1997 and 1998-2011.

## State Level Proceedings

As was previously mentioned, inmates are constitutionally entitled to a Direct Appeal in the Florida Supreme Court following a death sentence. Although not the focus of statutory changes, this process was examined first for delays. The average amount of time devoted to the Direct Appeal prior to 1998 was 2 years, 6 months; whereas, the average Direct Appeal length from 1998 to the present was 2 years, 7 months. Interestingly, while the maximum time between the initial filing of the Direct Appeal and the final disposition decreased after 1997, the minimum time increased. This indicates less variance in the overall lengths of time to complete a Direct Appeal, suggesting that filings are being disposed of in a more uniform manner.

A considerable amount of time spent on appeals is also devoted to the filing of the post-conviction motion (3.850 or 3.851<sup>3</sup>) in the circuit court as well as the appeal of this decision in the Florida Supreme Court. Prior to 1998, the average amount of time taken to complete a 3.850 motion in Circuit Court was 3 years, 5 months. The length of the 3.850 or 3.851 motion was considerably shorter after 1997, averaging just 1 year, 11 months. The longest time to complete a postconviction motion decreased after 1997, from 15 years, 6 months to 12 years, 2 months.

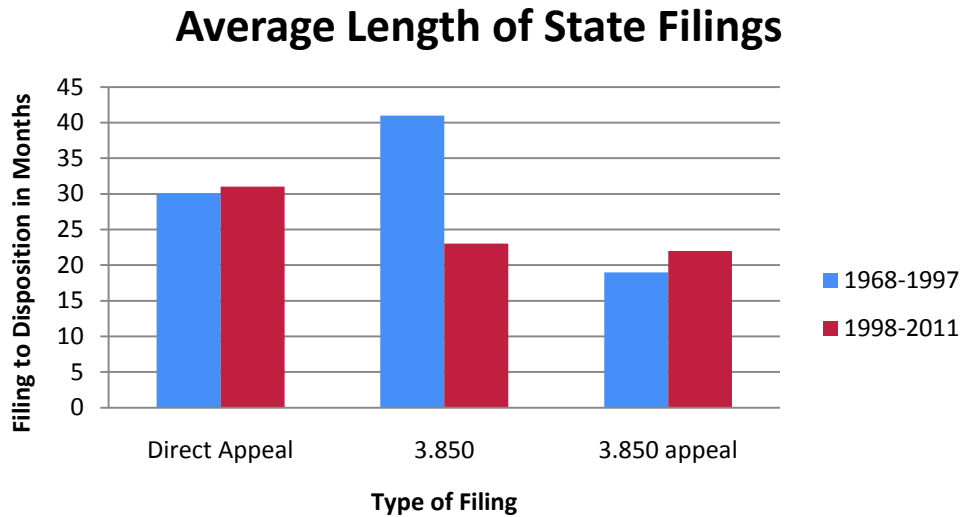

The average time spent appealing a 3.850 denial in the Florida Supreme Court before 1998 and from 1998 to present varied minimally. The average lengths of time were 1 year, 7 months and 1 year, 10 months, respectively. The longest time to complete a postconviction motion decreased after 1997, from 10 years, 4 months to 5 years, 10 months.



No comparisons between time periods could be made for the filings of 3.853 motions and appeals due to the fact that there were none were filed before 1998. However, the average length of time a 3.853 motion spent in the Circuit Court was 1 year, 1 month, and the average length of time a 3.853 appeal spent in the Florida Supreme Court was 1 year, 3 months. Both of the aforementioned times are comparable to the length of time 3.850 motions and appeals take to complete from 1998 to present.

## Federal Proceedings

Due to recent interest in the delays in capital case proceedings, the Commission on Capital Cases also decided to look into the length of time of appeals at the federal level. This involved the examination of all federal filings on behalf of death row inmates since 1998. In total, there were 705 filings on behalf of death row inmates during this time period. The majority of the filings were in the United States Supreme Court(348), followed by the United States District Court(219), and finally the United States Court of Appeals(138). The average length of time, from filing to disposition, of federal proceedings varied drastically from court to court. The court that disposed of their cases in the shortest amount of time was the United States Supreme Court. There, the average length of proceedings was just 3 months. Proceedings in the United States Court of Appeals took longer, with the average filing being disposed of in just over a year. Proceedings took the longest amount of time in the United States District Court where 2 years, 6 months was the average.

In addition to the issue of timeliness of proceedings, the Commission also looked into the incidence of inmate relief in the 3 federal courts. Inmate relief refers to any ruling in favor of the inmate (e.g. the granting of a habeas petition, the reversal of a district court judgment on appeal, etc.). Relief was rare in all courts, but was the rarest in the United States District Court. There, only 3 of the 219 habeas petitions were granted during the study observation period. In the United States Court of Appeals, the court vacated the District court judgment in just 5 of the 138 cases. The United States Supreme Court provided the most relief for death row inmates, granting 7 of the 348 Certiorari petitions.

<sup>5</sup> There were several cases in the U.S. District Court that were administratively closed or held in abeyance for a period of time and later reopened. The average length of proceedings in the U.S. District Court with these cases removed is 2 Years, 3 Months.
